#### **G. RESPONSIBLE GAMBLING**

Casinos Grup Peralada is developing a **Responsible Gambling** policy based on the deployment of European Responsible Gaming standards.

The Responsible Gambling policy has three main objectives:

- Identifying, controlling and reducing the possible negative impacts that the selection of casino games may cause.
- Contributing to creating a culture of games of chance where taking part in this activity happens within limits that gamblers can manage.
- Collaborating in research in the field of immoderate gambling and with organizations that work with people addicted to gambling.

Casinos Grup Peralada is committed to continuing to implement measures and actions aimed at including Responsible Gambling concepts and practices in its daily business activity in the future.

Games of chance are leisure activities that generate a space for entertainment and socializing and have accompanied human beings throughout history. In Catalonia, a number of different types games are played including lotteries, casino games, bingo and slot machines with a prize.

Although most people approach games of chance responsibly, gambling without limits can lead to serious problems for gamblers and their home and social environments.



The aim is to promote a new gambling culture, where this activity is approached as a means of entertainment with affordable limits. The Catalan Government is also working within the scope of the healthcare field with people with gambling addictions.

## DO YOU KNOW HOW TO KEEP YOUR GAMBLING UNDER CONTROL?

The essential element for gambling to become immoderate is the loss of control over this activity. This occurs when the gambler spends too much money or devotes more time to gambling than he can afford.

The questions you will find in the questionnaire we provide you here will help you find out whether you or someone in your family or social circle may have a problem with the way he gambles.

# ADVICE FOR RISK-FREE GAMBLING

Some of the practices that form part of Responsible Gambling are:

- Establishing a budget before going to play and never going beyond it. This budget must be part of your leisure expenses and under no circumstance may come from the money allocated to your daily living expenses.
- Never asking for money for gambling.
- Setting a time limit to spend on gambling and taking frequent breaks when gambling.
- Never going to gamble if you feel depressed or if you want to forget about your everyday problems.
- Preferably, gamble in a group and do it as a recreational and social activity.
- If you lose money that you bet, don't try to get it back. You must accept it as part of the game. Gambling more does not mean that we will win.

Do you think that someone in your family or social circle has a gambling problem?

Below, we provide you with some advice:

- Talk to the gambler and have a family member or friend go with you. Choose the best time. For example, when he expresses remorse about gambling.
- This person may not realize that he has a problem. So, understanding and tolerance are important when talking with him.
- Keep the focus of attention on the immoderate gambling behavior and not on the gambler.
- Get the person to see the impact of his actions on family and friends. Get him to see how the consequences of his addiction affect the people around him.
- Speak with a mental health specialist who will be able to guide you.
- Remember that changes take time. The person concerned may relapse a number of times before successfully overcoming his problem. Give him your support with every step he takes to recover.

#### Self-exclusion from gambling venues

When we play games of chance in a moderate and healthy way, we do this activity as a leisure activity. We are following the guidelines of responsible gambling. But if we do this activity immoderately and without limits, gambling can become an addiction and can cause serious problems in our personal, family and social life.

People who suffer from gambling addiction or who consider themselves to be at risk of suffering from it may voluntarily request to be banned from gambling rooms, casinos and bingo halls. They can do this by including themselves on the list of people who are prohibited from accessing gambling venues.

The registry is open from 8:30 a.m. to 2 p.m. from Monday to Friday at the headquarters of the Directorate General for Taxes and Gambling and/or at the Local Services of Barcelona, Central Catalonia, Girona, Lleida, Tarragona and Terres de l'Ebre.
